CALL TO ORDER

Chairman Claggett called the regular meeting of the Davison County Board of Commissioners to order at 9:00 a.m. Members of the Board present were Claggett, Kiner, Reider and Bode. Absent Weitala. Also present was Auditor Kiepke.

PLEDGE

The Pledge of Allegiance was led by Chairman Claggett.

APPROVE AMENDED MINUTES

Motion by Kiner, second by Bode to approve the minutes from the April 14, 2015 meeting. All members present voted aye. Motion carried.

DISCUSSION

Planning and Zoning Administrator Bathke reported that Burn Ban updates will be updated weekly on the Davison County website. He also stated that 49 out of 66 counties are under a burn ban.

DISCUSSIONS

Bathke also reported that drainage tile has been cut twice on Spruce Street. As of now, the contract says that it is up to the County Drainage Administrator to fix it. The contract will be modified so that the City of Mitchell will now be responsible.

APPROVE PART-TIME REHIRE

As the Davison County jail, under contract, was responsible for guarding a Hanson County inmate 24/7 while in ICU at Avera Queen of Peace hospital and the jail did not have enough staff to cover, motion by Bode, second by Reider to re-hire Carol Radel as a part-time corrections officer. All members present voted aye. Motion carried.

APPROVE FUEL QUOTE

Motion by Bode, second by Reider to approve the quote for 3500 gallons of 90/10 gas at a price of \$2.1819 per gallon. No other quote was received. All members present voted aye. Motion carried.

REMOVE WEIGHT LIMITS

Motion by Bode, second by Kiner to remove all temporary Spring weight limits effective April 22, 2015. All members present voted aye. Motion carried.

RECESS BOARD OF COMMISSIONERS/RECONVENE 2015 BOARD OF EQUALIZATION

Motion by Reider, second by Bode to recess Board of Commissioners and reconvene the 2015 Board of Equalization. All members present voted aye. Motion carried.

CORRECT ERRORS

Director of Equalization Goetsch informed the Board that several Mobile Home penalties were calculated incorrectly which will result in several refunds and internal adjustments.

Motion by Kiner, second by Bode for Wayne Gronseth, parcel number 05150-10261-00310, described as Lot C, Millers Addn, Lisbon Twp, Davison County, SD to accept the recommendation of the Director of Equalization to reduce the value of Abstract Type AG-C from \$380,285 to \$330,720 due to parcel being inundated with stones. All members present voted aye. Motion carried.

QUARTERLY WELFARE REPORT

Welfare Director Grissom presented the 1st quarter of 2015 Welfare report. The report shows there are 2 appeals pending from 2011 with potential liability of \$10,101.04, 5 appeals pending from 2012 with potential liability of \$25,273.37 and bills still being received for 2013 and 2014. PURR N RUFF RESCUE FUNDING REQUEST AND UPDATE

Gail Hahne, founder of Purr N Ruff Rescue appeared before the Board to request funding to help with costs associated with rescues. She specifically asked for \$600 a quarter to help cover expenses for gas, utilities and other costs associated with rescuing and placing dogs. She reported that as of January 1st, 2015 Globe University in Sioux is being utilized for spaying, neutering, vaccinations and micro-chipping as there is no charge.

She also requested a \$250 gift card for dog food, per quarter. At this time, the commissioners took no action and will make a decision next week as to whether there is funding available at this time.

APPROVE KIBBEE DITCH STUDY

At the request of Drainage Coordinator Bathke, motion by Kiner, second by Reider to approve Engineering Services for a drainage study proposal of \$40,400 from SPN & Associates for Kibbee Ditch. As the City of Mitchell will benefit from the study as well, they have agreed to pay \$15,100. The County will be responsible for the remaining \$25,300.

The County Coordinated Drainage Ditch was created in the early 1900's. There have been several joint meetings with the county officials, city officials and affected land owners to design a system acceptable to everyone. All members present voted aye. Motion carried.

APPROVE EXPENSE

At the request of Register of Deeds Young, motion by Reider, second by Bode to approve an expense of approximately \$2,457.78 to film back records from the digital record on roll film by the State Records Management Department and to store the original film on-site at Records Management in Pierre, SD in a temperature controlled environment. All members present voted aye. Motion carried.
