DRAINAGE BOARD January 16, 2024

CALL TO ORDER

Auditor Kiepke called the regular meeting of the Davison County Drainage Board to order at 7:00 p.m. Auditor Kiepke took roll call as follows: Members of the Board present were Jay Larson, Gregg Bult, Mark Klumb, Jerry Buchholz, Commissioner Kiner. Ex-Officio members present were Drainage Administrator Bathke, Assistant Wegleitner and Auditor Kiepke. Absent Edinger, Nebelsick, Highway Superintendent Weinberg and DOE Weber.

Guests in attendance were Bryce Gillan, John Millan, Mike Deinert, Dave Deinert.

OATH OF OFFICE

As this is the first meeting of the year, Auditor Kiepke administered oath of office all Drainage Board members present.

ELECT CHAIRPERSON

Auditor Kiepke called for nominations for a chairperson. Motion by Kiner, second by Bult to nominate Larson as chairperson. Auditor Kiepke called for other nominations three times. Hearing none, motion by Klumb, second by Bult that nominations cease, and a unanimous ballot be cast for Larson. A roll call vote was taken as follows. Buchholz – aye, Bult – aye, Edinger – absent, Larson – abstain, Kiner – aye, Nebelsick – absent, Klumb – aye. Motion carried.

ELECT VICE-CHAIRPERSON

Auditor Kiepke called for nominations for a vice-chairperson. Motion by Bult, second by Klumb to nominate Edinger as vice-chairperson. Auditor Kiepke called for other nominations three times. Hearing none, motion by Kiner, second by Buchholz that nominations cease, and a unanimous ballot be cast for Edinger. A roll call vote was taken as follows. Bult – aye, Buchholz – aye, Edinger – absent, Klumb – aye, Kiner – aye, Nebelsick – absent, Larson – aye. Motion carried.

CHAIRPERSON TAKES OVER MEETING

At this time, Chairperson Larson took over the remainder of the meeting.

MEETING EXPECTATIONS

Chairperson Larson recited expectations of the meeting.

A checklist of items required in accordance with the Davison County Drainage Ordinance and SDCL 46A-10A will be considered on each permit. The checklist is on file in the Davison County Auditor's office and Drainage Administrator's office.

APPROVE AGENDA

Motion by Bult, second by Klumb to approve the agenda for the January 16, 2024, meeting. All members voted aye. Motion carried.

DECLARE CONFLICTS OF INTERESTS

Chairperson Larson asked for any conflicts of interests. No conflicts were declared.

APPROVE MINUTES

Motion by Buchholz, second by Bult to approve the minutes of the October 17, 2023, meeting. All members present voted aye. Motion carried.

PUBLIC INPUT

Chairperson Larson asked for any public input public input for items not on the agenda and reminded the public that no action will be taken. Hearing none, the meeting moved forward.

CONSIDER MILLAN ACRES, LLC DRAINAGE REQUEST

Motion by Klumb, second by Kiner, based on findings, to grant a drainage permit to drain the following, the E $\frac{1}{2}$ of the SW $\frac{1}{4}$ of Section 36, T 103 N, R 62, W of the 5th P.M., Davison County, South Dakota, as requested by John Millan.

The plan is to install approximately 51,464' of perforated 4", 6", and 8" pipe in the E ½ of the SW ¼ of Section 36, T 103 N, R 62, W of the 5th P.M., Davison County, South Dakota, with a 10" perforated outlet transferring the water the SW ¼ of Section 30, T 103 N, R 61, W of the 5th P.M., Davison County, South Dakota. The water will then travel north in an un-named stream to the Dry Run Creek, then into the lower Firesteel Creek, then the James River, then to the Missouri River.

Application received: December 27, 2023

Applicant and necessary neighbors notified: December 29, 2023

Published: January 3, 2024

Administrator Bathke stated there was one call from abutting property owners or other residents. After receiving an explanation, the person decided not to attend the meeting.

Mike Deinert spoke in favor of granting the permit. He said that he had talked to neighbors and his brother David. It was agreed there would be no detriment to neighboring landowners.

Mr. Millan stated that he would be responsible if there are no easements in place with landowners.

Board members were given a few minutes to review the items to consider prior to making a decision, in accordance with Section 2:05 of the Davison County Drainage Ordinance. The items were placed on the screen for all to view.

A roll call vote was taken as follows.

Klumb – aye, Kiner – aye, Buchholz – aye, Bult – aye, Larson – aye, Edinger – absent, Nebelsick - absent. Motion carried.

ADMINISTRATIVELY APPROVED DRAINAGE APPLICATIONS

Administrator Bathke informed the Board there were no administratively approved applications since last meeting.

MISCELLANEOUS ITEMS

Administrator Bathke informed the board the Kibbee Ditch Drainage Project has been completed and we expect the Judge to sign off on dismissing the Bechen lawsuit. In the end, this lawsuit against the City of Mitchell cost Davison County \$84,137 (68%) and the City of Mitchell \$40,502 (32%). The City of Mitchell refused to pay Davison County \$2,762.50 for half the installation costs of the culverts.





Mr. Lowrie,

On June 18, 2013, the Drainage Board approved a permit in the W½ of the NE¼ of Section 9, T 101 N, R 60 W, pending stipulations. You installed the drainage project, yet failed to comply with the stipulations, rendering the project illegal. You presented other ideas to remedy the situation but failed to follow through with any of them.

At the February 19, 2014, Drainage Board Meeting, the board instructed you to install a gate in the drainage system to stop the release of any water.

At the July 15, 2014, Drainage Board Meeting, you presented a plan to utilize the original drainage permit but pump the water from the outlet to the south and connect the transfer pipe to an existing drainage system you have in the SE ¼ of Section 9-101-60.

At the August 20, 2019, Drainage Board Meeting, the board agreed to give you 60 days to complete the revised drainage plan for a permanent power source. Upon the deadline, there would be a fine imposed, as per Section 6:04 of the Drainage Ordinance, of \$250 per day until it is complete. The 60 days came and went without power or an operating pump to the property. However, once again, we allowed you time to remedy the power situation with the PUC. As of the March 17, 2020, meeting it had been 149 days past the deadline, and water was still flowing freely into the ditch and neighboring property.

At the March 17, 2020, board meeting, the board reinstated the \$2,500 penalty, which you paid. The full timeline is attached.

Once again, you have failed to properly maintain the system, allowing water to push to the north and east of the pits. This is considered a violation of the negotiated terms of your permit, which will be considered by the board. The Davison County Drainage Commission will hold a public hearing on said request on Tuesday, May 21, 2024, at 7:00 P.M., in the Commission Room of the Davison County North Offices, located at 1420 N. Main St., Mitchell, SD 57301. You are highly encouraged to attend.

Glen Lowrie Drainage Timeline

- 6-18-2013 The Drainage Board approved a Drainage Permit for Glen Lowrie in the W ½ of the NE ¼ of Section 9, T 101 N, R 60 W, pending 1) written approval from Doug Miller to cross his land and 2) written approval from the Rome Township Board for the pipe to cross the township road (263rd St.). See Drainage Board Minutes 6-8-13.
- 7-16-13 Drainage Administrator Bathke reported to the Board that Mr. Lowrie had not come in showing that conditions placed on his drainage permit approval on June 18, 2013 had been met. The Board agreed that it may take more time for the conditions to be met. See Drainage Board Minutes 7-16-13.
- 8-27-13 Drainage Administrator Bathke reported to the Board that after last month's meeting he spoke to Mr. Lowrie regarding the fact that he had not come in showing that conditions placed on his drainage permit approval on June 18, 2013 had been met. Mr. Lowrie stated that he still had beans in the field so he has not addressed the issue yet. The Board agreed to give him time to harvest. See Drainage Board Minutes 8-27-13.
- 9-27-13 Again spoke with Glen, nothing had been accomplished.
- Minutes show Glen Lowrie's violation was on the Agenda, but he re-routed the outlet to drain onto his own property via a lift station and pump, so his case was continued. See Lowrie Lift Station Application.
- The following discussion was held during the meeting. In June 2013, Glen Lowrie requested a drainage permit to remove excess surface water using 4", 6", 8" and 10" perforated tile. The location of the drainage is the W ½ of the NE ¼ of Section 9, T 101 N, R 60 W; which will outlet into 12 Mile Creek, using solid tile to get from Mr. Lowrie's land to the creek. The "as designed" and "as installed" are not the same, resulting in a change in the outlet and flow of the water. Mr. Lowrie was asked to explain the installation to the board.

Concerns from Doug Miiller were that no matter what Mr. Lowrie does, because of the drainage pipe he had installed different than how it was approved in June of 2013, water will pool up and affect landowners.

After discussion, motion by Weiss, second by Bult to deny the drainage permit requested by Glen Lowrie and along with the denial Mr. Lowrie was informed by the Davison County Drainage Board that he is to gate the drainage pipe on his property by April 1, 2014, at Mr. Lowrie's own expense. A roll call vote was taken as follows. Schilling – aye, Edinger – aye, Larson – aye, Kiner – aye, Buchholz – aye, Weiss – aye, Bult – aye. Motion carried.

Drainage Administrator Bathke reported that two months ago Glen Lowrie was denied a drainage permit and was given two months to put a locked gate on. As of April 1st, 2014, the gate has been installed. The gate is not to be opened without approval from the Drainage Board.

Doug Miiller stated that everybody should be allowed to put a gate in, then. He believes Mr. Lowrie's should be dug out every 50'. But, he stated, the bottom line is he wasn't supposed to do it the way he did.

Don Garves believes there should be more caps mandated for Lowrie. He also believes it is wrong to have caps next to fence. He stated that water will pool next to the township road and will saturate it.

Edinger stated that Mr. Lowrie is not able to drain properly with the means installed. He further stated that if water creates problems, he will have to take additional measures.

Commissioner Kiner believes that it was an illegal act and should be turned over to the States Attorney. Drainage Administrator Bathke will deliver the case to the States Attorney's office.

4-16-14 As Mr. Lowrie had not addressed the drainage system, a letter was sent to him with the following text:

The Davison County Drainage Commission then met on February 19, 2014 at 9:00 A.M., in the Commissioners Chambers of the Davison County Courthouse. The Commission found the drainage was not installed as designed or approved, and the short term decision was made to require you to install a gate in the outlet prior to April 1, 2014; in an attempt to stop water from entering the Township road ditch, until a long term plan could be designed for the drainage system. Section 6:03 of the 2013 Revised Drainage Ordinance of Davison County, as stated below, authorizes the Drainage Commission to prevent the unlawful construction or use of any drainage work.

Recently, at the April 14, 2014 meeting, discussion included the gate installed being sufficient enough to stop water from draining out of the installed pipe and into the ditch. The gate was a short-term plan and not a long-term solution. Upon design of a long-term solution, you will be required to present this to the Drainage Board. However, due to the installation without a legal permit; the Drainage Board has decided to turn this matter over to the States Attorney's Office for prosecution.

Board Meeting Minutes: Glen Lowrie whose property is legally described as the W½ of the NE¼ of Section 9, T 101 N R 60 W of the 5th P.M., Rome Twp, Davison County, SD had previously been granted a drainage permit but failed to

comply with the provisions of the permit, appeared before the Board to ask that he be allowed to install a small lift station to the north where the drain is capped.

Don Garvis wondered if the water still wouldn't pool. Mr. Lowrie stated that he will back-up the lift station to help prevent pooling.

Doug Miiller expressed that he would like the lift station backed up to the south.

Tim Kummer is concerned about the amount of water this will cause to go into his field.

Delmar Mueller was concerned because when he left the April drainage meeting, he was under the understanding that drainage would not be allowed on the 80 acres in question.

Bathke stated that the original plan was approved, pending landowners to the north approval which didn't happen. Mr. Lowrie was instructed to come back with a suitable plan. He was further instructed that the drain would need to be capped until an approvable plan was brought to the Board.

Motion by Kiner, second by Weiss to approve Lowrie's project pending written approval from adjoining landowner Tim Kummer. A roll call vote was taken as follows. Kiner – aye, Buchholz – aye, Weiss – aye, Larson – aye, Schilling – aye, Edinger – absent. Motion carried.

- 5-29-14 Another letter was sent to Mr. Lowrie
- Board Meeting Minutes: Glen Lowrie whose property is legally described as the W½ of the NE¼ of Section 9, T 101 N R 60 W of the 5th P.M., Rome Twp, Davison County, SD and the SE¼ except Lot A of Glen Lowrie's first addition and except the portion of property measuring 439.01' (ft) N and S and 170' (ft) E and W adjacent to Lot A of Glen Lowrie's first addition of Section 9, T 101 N R 60 W of the 5th P.M., Rome Twp, Davison County, SD presented an updated plan that would utilize the original drainage permit issued in 2013 (minutes are in error and say 2011) with the outlet in the SW¼ of Section 10.

Mr. Lowrie would like to place a small lift station and pump in the W $\frac{1}{2}$ of the NE $\frac{1}{4}$. It would be installed this fall about 200' (ft) away from ditch and would run south to the SE $\frac{1}{4}$ and eventually through Thiesse's property which is all CRP grass.

At the last Drainage Board meeting, Mr. Lowrie was to get written permission from Mr. Tim Kummer for his drainage plan. Mr. Kummer, who was present at the meeting, said this new plan would not affect him.

Motion by Edinger, second by Weiss to approve the new outlet into a blueline creek with a minimum 200' (ft) setback from the north boundary of the property. A roll call vote was taken as follows. Larson – aye, Kiner – aye, Buhholz – aye, Weiss – aye, Bult – aye, Edinger – aye, Schilling – aye. Motion carried.

- June 2019 Jeff received several calls from Lyle Lowrie, stating water is still flooding his property.
- 6-10-2019 Jeff called Tim Kummer to discuss any negative effect he was having to his field in the NW ¼ of Section 10-101-60. Tim stated he is having additional water come his way this year, which he should not have to accept.

The lift station is not maintained, causing water to overflow to the northeast into the road ditch, Lyle Lowrie's property, and Tim Kummer's property. Allowing water to flow into the road ditch is against the Ordinance. The pump runs when Mr. Lowrie wants to put fuel in the pump.

- 8-20-2019 At the August 20, 2019 Drainage Board Meeting, the board voted to allow Mr. Lowrie 60 days to get this project completed. Upon the deadline, there will be a fine imposed, as per Section 6:04 of the Drainage Ordinance, of \$250 per day until it is complete. Mr. Lowrie is also to report to Drainage Administrator Bathke on a regular basis the progress being made.
- 9-22-2019 Lyle Lowrie called me and said the pump has not run at all since the 9-11-19 flooding, with the water flooding his pasture.
- 9-25-2019 Glen reported he had not heard anything from PUC or Central Electric regarding the approval for Central Electric to bring in service. He is hoping to get the service line buried from road to the lift station soon, in anticipation of the PUC and CE approving the service. That way all that needs to be done is hook into the transformer and should be good to go. It is very wet in the field in that corner.

He states he has been pumping it with a transfer pump to keep it below running out of the hole on the north. He feels he has been able to keep up that way except for the big rains we had. He has plans for the electrician to bury the line on 9-25-19. Jeff was out there on 9-25, but did not go in the field. Glen was at the pump, but Jeff did not see a generator. The ground was not overly saturated as one would expect. Doug Miiller stopped while Jeff was there and said Central Electric was in the field a couple days ago.

Glen informed me Jeff still has not heard from the PUC on the release for Central Electric. He is moving forward with having an electrician get the service wire and panel installed on 10-9-2019; even though he does not have approval from Central Electric to provide power.

- 10-20-2019 60 day deadline to complete the project.
- 10-21-2019 Glen left a message explaining Central Electric is waiting for paperwork from Northwestern Energy and nothing has been submitted to the PUC yet. Glen has installed the service line, which can be connected to the transformer once the PUC approval is completed.


According to the direction of the board, with no power supplied to the pump by the deadline, this matter is forwarded to the States Attorney's Office for prosecution.

- 10-23-19 Jeff informed the Drainage Board and States Attorney's Office the timeline above. Mr. Taylor responded requesting we contact Central Electric, NWPE, or the PUC prior to any prosecution.
- 10-25-19 Ken Schlimgen from Central Electric called to inform me this was not on the PUC's Agenda.
- Brian Bultje from Central Electric stopped by the office to give an update on the Lowrie project. He said that once they received notice it was an illegal drainage project, they halted everything and tried to get into contact with Glen but had wrong contact information. They have since contacted Glen about the project. This was not on the November PUC agenda, but might be on the December agenda. If approved, they will not be able to do anything till spring assuming the ground will be frozen.
- Deputy Jenniges drove by the site to see that a wire had been buried from the lift station hole to the right of way with a wire coiled out of the ground (see photos below). There is no generator running and there is water from the hole to the north and into the ditch almost all the way to 409th with some backing up into Lyle Lowrie's land.
- 12-5-19 Letter received from Mr. Taylor recommending more information before we move forward with injunction.
- 12-26-19 Letter received from Mr. Loker recommending we move forward with injunction.

- 11-25-19 Drainage Administrator Bathke spoke with Lorena at the PUC. Northwestern Energy would need to release the customer and Central Electric would need to accept the customer. The PUC has not received a docket yet for this request. PUC meetings are every two weeks, so they can get it on at any time.
- 1-31-20 Drainage Administrator Bathke spoke with Lorena at the PUC. In a search of the PUC minutes, this request was *not* found on the PUC Agenda. According to Lorena, the PUC has received and approved the request. Email sent to Mr. Taylor. We agreed to give Central Electric time to install the line, since it is now approved by the PUC.
- 2-3-2020 Jeff informed the board and sent Mr. Lowrie a letter informing him he needs to work with Central Electric to have the service installed as soon as weather permits.
- Administrator Bathke gave the board an update on the Glen Lowrie Illegal Drainage 3-17-20 Project. At the August 20, 2019 Drainage Board Meeting, the board agreed to give Glen Lowrie 60 days to complete his revised drainage plan. Upon the deadline, there will be a fine imposed, as per Section 6:04 of the Drainage Ordinance, of \$250 per day until it is complete. He needed to get the PUC to agree to allow Central Electric to provide service in Northwestern Energy's territory. His 60 days came and went without power or an operating pump. We were working with the States Attorney's Office to move forward with an injunction. Administrator Bathke had intensions of holding a board meeting in February 2020 to make this action official. Prior to the meeting, Administrator Bathke spoke with the PUC. On January 7, 2020 they approved the utility transfer and closed the docket. As soon as weather allows, Central Electric will install the service. They will not dig any lines until April 1, 2020. Glen has already buried the line from the pit to the road, so Central Electric will only need to install a line across the right of way, and up the road a short distance. Due to this development, we did not have a board meeting, and allowed Central Electric some time to install. Administrator Bathke encouraged Glen to keep in touch with Central Electric to have this completed ASAP. All PUC documents can be found at the following link: https://puc.sd.gov/Dockets/Electric/2019/EL19-042.aspx. On March 17, 2020 Mr. Lowrie

was informed he needs to continue to pump the water with his generator until the hard wire is installed. At this time, he has no generator on site, and the field, ditch, and neighboring field is full of water. It has now been 149 days past the deadline. At \$250 per day, the fine would be \$37,250. We have been dealing with this case so long that two of the original complainants have since deceased. The board discussed reinstating the \$250 per day penalty, with a maximum of \$2,500. Motion by Jerry Buchholz, 2nd by Gregg Bult to reinstate the \$250 per day fine, with a maximum penalty of \$2,500. Motion approved on a 6-1 vote. Board Member Brenda Bode voted no but wanted the board to know she was voting no because she feels the penalty should be more than \$2,500. The next board meeting is April 21, 2020. If the pump is not running at that time, the board will review the case and initiate another penalty. Mr. Lowrie was notified by email and followed up with a letter.

4-1-2020 Letter was sent to Glen Lowrie, with penalty and notification of April 21, 2020 meeting. Mark went to the site to see if Glen has set up a generator on his lift station just west of 409 & 263; as well as where the water is going. Lori Kummer is frustrated, as Tim just passed away and she was out there, and her field was very wet. She questioned if Glen was pumping water her way. Mark's report-It was the driest I have seen it by the north pump. There was no water outside the two holes that he had sump pumps in. They were running and sending water south. There was still water in the ditch on 263 and some water on Lyle's field. The lift station to the south was working and collecting all the water, no more water was running northeast and through those culverts. There was standing water northeast of the lift station, I'm assuming from before and it's just sitting there. As long as the pumps are running it should work as planned. I did end up talking with Central Electric. They were looking at the lift station when I first saw them. They are planning to move the power to higher ground once it dries up. Also the direct power for the north pump is high on their list. Depending on amount of precipitation this weekend it could be within the next week or two if not much and stays dry.

4-29-24 The Drainage Office received several complaints of water pouring out of the pump pits. Upon inspection, it was clear the breakers were not on and a large amount of water had was running to the north and east. Glen was notified. He left a message later that night stating that he corrected the situation.






Certified Wetland Determination
