Davison County Resolution #070924-01 Grant Temporary Malt Beverage License to Exchange Club of Mitchell, SD

Whereas, SDCL 35-4-124 states, in part, that any municipality or county may issue:

- (1) A special malt beverage retailers license in conjunction with a special event within the municipality or county to any civic, charitable, educational, fraternal, or veterans organization or licensee licensed pursuant to 35-1-111 or subdivision 35-4-2(4), (6) or (16) in addition to any other licenses held by the special events license applicant;
- (2) A special on-sale license in conjunction with a special event within the municipality or county to any civic, charitable, educational, fraternal, or veterans organization or any licensee licensed pursuant to 35-4-111 or subdivision 35-4-2(4) or (6) in addition to any other licenses held by the special events license applicant; and

Whereas, a public hearing is required for the issuance of a license pursuant to this section if the person/organization applying for the license doesn't hold an on-sale alcoholic beverage license or a retail malt beverage license in the municipality or county; and

Whereas, no persons appeared at the hearing held June 27, 2023, in objection to the issuance of the malt beverage license applied for and no concerns were otherwise expressed, it being noted the location and particulars of the temporarily licensed premises were appropriate for the sale of malt beverages.

Whereas, the fee had previously been set at \$200.00.

Now, therefore, be it resolved, that a temporary on-sale malt beverage license be issued to Exchange Club of Mitchell, SD, for a fee of \$200 for the days of August 20, 21 and 22, 2024, for DakotaFest, which is held in the SE ½ Inc, Lot A of Moneke's Sub Ex H2 & Ex Schlaffman Tract 1 and the SW ½, Ex H2 & Ex Lot A of Mitchell Landfill, 1st Addn & Lot 7 N of H-3 SE ¼, Mitchell, Township, Davison County, South Dakota.

THIESSE DRAINAGE ISSUE

Steve Thiesse appeared before the Board to discuss a drainage issue he has because he has talked to the City of Mitchell and County officials and hasn't been able to get a resolve. He stated his problems began when the City placed a pipeline in his ditch. The water hasn't drained correctly since.

Highway Superintendent Weinberg said they have cleaned the ditch and the water will drain, it just takes a while.

The commissioners determined there needs to be a discussion between the City, Weinberg and Bathke to determine a resolution for Mr. Thiesse.

SMITH WEED DISCUSSION

Jay Smith received a bill in the mail from the Davison County Weed Department for weed eradication. He stated he was in the process of getting rid of the weeds and didn't feel the timeframe allowed was fair.

He posed several questions to the Board. He asked which of the commissioners served on the Weed Board and if they were entitled to be part of the destruction of his property.

Chairperson Reider responded stating that if the Weed Department aren't able to get things done in a timely manner, they may hire custom help.

Deputy States Attorney Taylor said that if weeds are not taken care of in a timely manner, as per SDCL 28-22 the County, giving timely notice, can come in, take care of them and bill for the service.

Weed Supervisor Page stated that he treats every landowner the same. They get five days to take care of weed infestation.

Mr. Smith wanted to know if Facebook is a legal way to post meetings of the Weed Board.

Chairperson Reider responded saying that posting on Facebook is in addition to the required notice.

He asked about minutes of the Weed Board meetings and was told they are all kept at the Weed Department.

Mr. Smith asked again if there was a conflict with a commissioner being involved.

Commissioner Nebelsick responded saying that he should be thanking him for getting rid of his weeds as his neighbors were going to sue him.

Mr. Smith mentioned a dam just south of the corner of 256th St. and 402nd Ave. and asked if it was legal to place it there. Highway Superintendent Weinberg will take a look at it.
