PUBLIC INPUT

There was no public input.

SUPERINTENDENT WEINBERG

Review of phone vote for 7,200 gallons of Diesel #2. Motion by Nebelsick, second by Kiner to approve the low bid of Vollan Oil at \$2.43 per gallon. Other bids included Brooks Oil at \$2.433 and CHS at \$2.67 per gallon. All in favor - aye. Motion carried.

Supt. Weinberg requested to purchase a probe and float for the in-ground fuel tank due to the sensors not working. Parts are estimated at \$3,505.00. Motion by Nebelsick, second by Claggett to approve the purchase. All in favor - aye. Motion carried.

Approve contract for Sire Lines-A-Lot for the striping of 17 miles of roads to be completed in 2025. The contract comes in at \$29,675.00. Motion by Kiner, second by Nebelsick to approve. All in favor - aye. Motion carried.

Motion by Nebelsick, second by Claggett to approve Chairman Reider to sign a contract with Civil Design to start designing for structure No. 18-080-007 located on 402nd Avenue between 244th and 245th Street. The full contract can be found in the Auditor's Office. All in favor - aye. Motion carried.

Supt. Weinberg talked to the board about getting a PE Grant for the bridge on 398th. Motion by Blaalid, second by Nebelsick. Roll call vote was taken: Claggett - nay, Kiner - nay, Nebelsick - aye, Blaalid - nay, Reider - nay. Motion failed. The board discussed how the project was not cost effective at this time due to the location and low travel. At this time, the road will be blocked off and closed to thru traffic. This specific road and bridge will continue to be monitored and discussed.

Equipment and blading rates discussion was held. Motion by Nebelsick, second by Kiner to approve the blading rates to be increased to \$140 an hour for both winter and summer maintenance. All in favor - aye. Motion carried.
